## Regular Monthly Meeting MARCH 13, 2013

The regular meeting of the Ovid Town Board was called to order at 7:00pm by Town Supervisor Walt Prouty, Also present were Councilmen John Hubbard, Mark Beardsley, and Joe Borst, Town Clerk James Vangalio, Deputy Town Clerk Michele Vangalio, Highway Superintendent Jack Wickham, Bookkeeper Donalie Kelly, members of the press and other interested citizens.

Minutes of the February 13, 2013 meeting were approved, as written, with a motion by Councilman Borst, a second by Councilman Beardsley and approval by all.

Petitioner to the Board, David Dresser spoke to the Board regarding the latest on hydrofacking.

Highway Superintendent Jack Wickham presented his report. Jack told the board he had received a donation form Mrs. Morrison of forms etc. for the Highway Departments use. Jack requested a thank you be sent to her. Jack's Transfer Station report was also presented.

The Town Clerk's Report and moneys collected for February were accepted into the record. As Land Use Officer, the Town Clerk reported on activity with land use permits within the town.

Board Members received the Bookkeeper's report.

Supervisor Prouty presented his report. With a motion by Councilman Hubbard, a second by Councilman Beardsley and approval by all the Board approved the Cayuga Lake Triathlon's request to hold their event on the Town's roads. Supervisor Prouty presented a resolution regarding the repeal of the Safe Act. Walt reported that he had sent a letter to the Village regarding obtaining a right of way for the Town to be able to park behind the building after the sale.

Planning Board member Paul Engineri addressed the Board regarding the Planning Board. It was agreed to hold a joint meeting with the Planning Board to discuss the survey.

Councilman Hubbard read Councilman Flood's report regarding the Planning Board and the Farm Bureau.

Councilman Hubbard presented his reports regarding EMS and Fire Departments.

Councilman Beardsley presented his report regarding the Assessment Department.

Councilman Borst presented his reports regarding the Highway Department and Transfer Station Councilman Borst read a letter from Justice VanCleef announcing the resignation of his Court Clerk Angela Champion. With a motion by Councilman Borst, a second by Councilman Hubbard and approval by all the Board accepted the resignation of the Court Clerk effective March 27<sup>th.</sup>

With a motion by Councilman Borst, a second by Councilman Beardsley and approval by all the Board passed Resolution 10-2013 appointing Michael Nash to the Planning Board.

With a motion by Councilman Beardsley, a second by Councilman Borst and approval by all the Board passed Resolution 11-2013 appointing Chris Verrill to the Board of Assessment Review.

With a motion by Councilman Hubbard, a second by Councilman Borst and approval by all the Board authorized the Clerk to advertise for mowing bids for the cemeteries, park, and Town Barns.

With a motion by Councilman Hubbard, a second by Councilman Borst and approval by all the Board approved Resolution 12-2013, asking for the repeal of the Safe Act.

Councilman Beardsley announced the "Burn Ban" will be in effect from March  $15^{\rm th}$  thru May 15th.

With a motion by Councilman Flood, a second by Councilman Borst and approval by all the Following the Audit of the bills, Vouchers #61-95 were approved for payment with a motion by Councilman Beardsley, a second by Councilman Borst, and approval by all, for Abstract #3 for \$55,656.99.

Supervisor Prouty adjourned the meeting at 8:01pm with a motion by Councilman Hubbard, a second by Councilman Borst, and approval by all.

### RESOLUTION 2013-12 CALLING FOR THE REPEAL OF THE NEW YORK SAFE ACT OF 2013

By: The Ovid Town Board

**WHEREAS**, the New York State Legislature recently enacted and Governor Andrew Cuomo signed into law The New York Secure Ammunition and Firearms Enforcement Act of 2013 ("NY SAFE ACT"); and

**WHEREAS**, the Legislation is viewed by many citizens of the State of New York as Being extremely controversial as those citizens view this Legislation as infringing upon their rights guaranteed to them under the second Amendment of the United State Constitution; and

**WHEREAS**, e ach and every issue that comes before the New York State Legislature before an enactment deserves a fair and open discussion which incorporates all points of view in order to ensure that all citizens are heard and that the Legislation incorporates the various points of view expressed during that discussion and benefits all of the citizens of the State of New York; and

**WHEREAS**, the NY SAFE ACT was adopted after minimal public discussion contains Serious flaws, I.e. police officers are not exempt and having been on the desks of the Members of the New York State Legislature for only a few hours, thereafter was literally adopted in the night and signed into law by Governor Andrew Cuomo; and

**WHEREAS**, in 2011amendments were made to the Open M meetings Law (Public Officers Law Section 103), requiring a public body prior to a meeting to post on its website, to the extent practicable, for public benefit all records that may be considered or discussed at that meeting; and

WHEREAS, A. 107 has been pre-filed before the New York State Assembly for the 2O13-2014 Regular Session, to amend the Public Officers Law (Sections 84 and 90) in relation to publishing records of public interest by agencies and the State Legislature, reading in part "...The people's right to know the process of governmental decision-making and to review the documents and statistics leading to determination is basic to our society. Access to such information should not be thwarted by shrouding it with the cloak of secrecy or confidentiality..." and

**WHEREAS**, the State of New York has a tradition and long history of conducting its deliberations and debates in the public view and that in the enactment of the NYS SAFE ACT the New York State Legislature and Governor Andrew Cuomo acted in contradiction of this long, time honored tradition of an open government, and

**WHEREAS**, the members of the Ovid Town Board at their regular meeting held March 13, 2013 at Ovid, New York wish to express their concern that any legislation which addresses the ownership of guns and the sale of ammunition in the State of New York be conducted only after an open debate pursuant to which the public is allowed to participate and express their points of view, now, therefore be it

**RESOLVED**, that the Ovid Town Board calls for the repeal of The New York Secure Ammunition and Firearms Enforcement Act of 2013 ("NY SAFE ACT");

**RESOLVED,** that the Ovid Town Board support the positions adopted by resolution from the New York State County Clerk's Association the State Sherriff's Association.

**RESOLVED**, that the Ovid Town Board hereby directs that certified copies of this resolution be forwarded to Governor Andrew Cuomo, members of the New York State Legislature, NYSAC, NACo, New State Association of Towns, and each New York State County.
